In an attempt to ensure the sustainable economic growth, the Government of Lao PDR is mainstreaming sustainable management of natural resources and environmental safeguard in the Socio-economic Development Strategy 2025 and the 8th Five-Year National Socio-economic Development Plan 2016-2020 in order to keep the country progress toward the environmental vision 2030 of "Green, Clean, and Beautiful Laos". During these country's strategy and five-year plan, natural resources and environment are taken as one of the 3 pillars of country development path.

With these new approaches, we consider ourselves as young implementer and therefore we are open for advises and technical assistance from our GMS member countries, in particular our development partners.

The operationalization afore-mentioned does fully reflect our international and regional interests on direction to move toward the sustainable development and the green growth pathway.
